6.0 SPECIAL PRESENTATION

6.1 CMS Report - HOPE Squad

Mari Kay Miller, Dean of Students, introduced several students to talk about Colerain Middle School's Hope Squad. Hope Squad is a school based suicide prevention group that helps teach kids about the risks and concerns around mental health. It mainly focuses on students and how they feel.

Hope Squad members are nominated and selected by their peers for being concerned about others, a good listener, easy to talk to and someone you can turn to if you need a friend. Nominated students are taught how to recognize the warning signs and symptoms of distress, and are empowered to help their classmates by notifying a trusted adult if needed.

The Hope Squad created an anti-bullying lesson that was presented during October for Anti-Bully Month and encouraged classmates to wear orange on October 19 for Unity Day. May 6-10 is Hope Week and each day of the week will have a theme and daily motivational announcements to encourage students to be accepting of others and to take pride in who they are.

The Hope Squad has had 8 students referred to counselors this school year for suicidal ideations and self harm. None of the students referred completed suicide.

6.2 CHS 100 Year Anniversary Proclamation

Ryan Holiday, Southwest Ohio Regional Liaison for the Auditor of State Keith Faber, presented a proclamation for Colerain High School's 100 year anniversary via video. The proclamation states:

In recognition and appreciation of Colerain High School's 100th anniversary celebration, 1924 - 2024.

Whereas Colerain High School was established in 1924 with one school and expanded to nine elementary schools, three middle schools, and two high schools becoming the Northwest Local School District; and

Whereas Colerain High School celebrates its 100th anniversary in the year 2024 it is fitting to recognize this special milestone and applaud its distinguished history; and

Whereas Colerain High School is an integral part of education in the Northwest Local School District jurisdiction.

Therefore I recognize Colerain High School's rich history and its students, alumni, staff and faculty as they celebrate this auspicious occasion.

7.0 COMMITTEE REPORTS AND UPDATES

A) Student Achievement Liaison Report

7.1 Student Achievement Liaison Report by Board Representative

Board Member Nancy Slattery presented the Student Achievement Liaison report as follows:

Monfort Heights Elementary

- Colin Schlemmer placed 8th in the state at the Ohio Athletic Committee State Wrestling Tournament. He was one of four Colerain Youth Wrestlers who qualified from the District.
- Kindergarten had several different community members come to speak about their responsibility to the community. Some examples were two dental hygienists from Delaet Dentistry, Colerain K-9 Unit, Green Township Fire Department, and local author Dana Schon.
- On March 28, published teenage author Ella Buckley, daughter of teacher Audra Buckley, spoke to 4th and 5th graders about the publishing and the writing process of her three books and how she gives back to the community with her earnings.

Colerain Elementary

- 2nd grade students participated in a March Madness Activity. 32 books were chosen and teachers read two books everyday. Students voted on their favorite of the two on a Google Form. Teachers tallied the votes and the winning book moved onto the next round. The final two books were The Big Cheese and Potato Pants. The winning book was Potato Pants.
- 3rd grade students participated in the second annual “The Floor is Lava” Ohio State Testing review. Students reviewed Ohio State Testing test items as well as test taking strategies in a format where students were literally doing everything humanly possible to not touch the floor as they maneuvered throughout the classroom. The safe zone on the floor was represented by the brown tile floor and the red paper represented lava. The students had an absolute blast and prepared for the Ohio State Testing in a very engaging way.

- 4th grade teachers set up Ohio State Testing teams. These teams helped to motivate the students to improve their writing response score on the rubric. These teams helped to increase scores on writing checkpoints given in preparation for the Ohio State Testing test given this Tuesday.

Struble Elementary

- 40 Struble students were recognized on Friday, April 12 at the monthly Blue Jay Breakfast. Students are recognized for following the Blue Jay Way: taking care of themselves, each other, and our school by working hard and showing kindness to others. Students enjoyed breakfast with a parent/guardian and received a T-shirt and an award with a personal message from their teacher.
- Students from the Multicultural Club shared information with our 2nd grade students about what they will learn at the performance of "The Pa'akai We Bring." Students learned that the play focuses on the multiple generations of Native Hawaiian people that have become salt farmers. The presentation included discussion of the islands of Hawaii and focused on Kauai, where salt harvesting takes place. The 2nd graders will hear ancient stories, live music, and see hula dancing.

Taylor Elementary

- 42 students received the Cooperation Award in March. To be recognized, students had to exhibit the ability to work well with others on a daily basis.
- 19 students are participating in Girls on the Run. Last week the students completed their practice 5K as several teachers and family members came to cheer on the students as they ran. The students will participate in a real 5K during the month of May.
- Mrs. Bischoff's classroom had 100% of students meet their MAP Goal. MAP stands for Measures of Academic Progress and is a three-part test that measures student knowledge in math, reading, language usage and science.

Pleasant Run Elementary

- This month, second graders came to school dressed as their favorite book character. They read a book, dressed like the character and shared a story summary with their classmates.

- 2nd and 3rd grade students practiced their thinking and communication skills as they used academic teaming to determine the main idea of the story and worked through some difficult math word problems.

Houston Early Learning Center

- The teachers have been tracking our preschoolers’ social and emotional learning in the areas of social regulation, approach to learning, and social interactions. They have already hit two of their three goals and anticipate hitting the last goal by the end of the school year.

C) Legislative Update

7.3 Legislative Update by Board Representative

Board Member Chris Heather presented legislative updates as follows:

Last week Governor Dewine gave the State of the State address. During the address he proposed banning the use of cellphones in schools due to the detrimental effect they have on the learning process. Bills have been introduced in both the Ohio Senate and the Ohio House of Representatives to address concerns about cellphone usage in schools. Some districts around the state have already implemented bans and seen positive results. We will continue to monitor this issue.

The Northwest Board of Education welcomes the opportunity to listen to Northwest Local School District resident’s comments, suggestions, and concerns on educational issues. It is important to remember that the Board conducts the meetings in public, but the meetings are not public forums. The intent of the meetings is to allow the Board to complete needed business. Per Board Policy (169.1), each submission will be given three (3) minutes to speak on agenda items of any topic during “Community Comments.” However, no more than fifteen (15) minutes will be devoted to public participation unless the Board votes unanimously to continue the discussion. No response to this submission will occur from any Board member or district administration during this time. Once the fifteen (15) minutes’ time frame is over, appropriate follow up by the district administration may occur at a later time if warranted.

Ryan Glace, parent of Pleasant Run Elementary fourth grade student: I’m coming up here with a very serious issue. Last Thursday, my daughter came home and mentioned something about Erin’s Law. I asked her if she knows what inappropriate touching means and she said yes. I asked her if she knows what to do if that occurs and she said “we have a lot”. That was concerning. She came to me a month or two ago and said there was a little boy in her class that was getting a little handsy. I told her to go talk to her teacher and explain what’s going on. The teacher’s response was “well, I guess he likes you” and my daughter’s response was that she’s not going to tell me (her father) what the teacher said because I’m not going to be happy. She went to the teacher a second time, nothing happened. She went to a substitute teacher, nothing happened. Then, she went to a counselor but she was out on maternity leave so she spoke to the substitute counselor who did nothing. She went to the school nurse, watched the school nurse type an email to her teacher saying “hey, this is inappropriate, can we handle this?” Again, the teacher did nothing.

I don’t mean to get upset here but we’re not talking about someone brushing up against her. We’re talking about him grabbing her rear end, grabbing her crotch, telling her she’s been a bad girl and needs a spanking. This is all happening as the school is asking about Erin’s Law. Friday morning I called the school and had an even more alarming conversation with the principal who basically told me my daughter’s lying. She said the person that would launch the investigation was not at work so

we'll get to it maybe Monday or Tuesday. Nothing happened Friday and nothing happened today (Monday). I want simple answers. She (the principal) should get out of her office, walk down to the teacher's room and say, "hey, I've got this issue, this girl's dad called, let's move him now. It takes five minutes to handle the situation instead of calling me a liar.

At Pleasant Run Elementary the fourth grade is doing a wax museum project where the student chooses someone born in America or who helped America. I'm thinking it's awesome, I love history, it's a great thing to do up until she tells me her teacher strongly encourages them to do Taylor Swift or Olivia Rodrigo - all these modern pop singers. I feel like this is a missed opportunity, there are people more important to America than that. It prompted a lot of conversations with my daughter when she was doing the research that I was not ready to have. My house is fairly conservative but her response was "well, those are your morals". And they are my morals, and I don't expect my morals to be pushed in school but I don't expect the school to challenge them either.

As far as the situation where a 10 year old girl comes up and tells someone that they're getting touched inappropriately and four different people up at the school don't do a thing...(time expired).

Discussion:

- **Mr. Yater:** We normally don't respond during this time but I don't want you to walk away tonight. I don't know if Dustin (Gehring) is still here or if Lori (Riehle) is here but I want you to talk directly with them because we need to dig deeper into this and make sure that your concerns are addressed. I want to make sure that you get access to someone tonight who can help address these concerns.

**MEMORANDUM OF AGREEMENT

WHEREAS, the Northwest Local School District Board of Education (“Board”) is a political subdivision organized under the provisions of Ohio Revised Code Chapter 33; and

WHEREAS, the Colerain School District Booster Association (“Colerain Boosters” or “Boosters”) is a non-profit service organization that provides major financial support and volunteer assistance to programs at Colerain High School, Colerain Middle School, and White Oak Middle School; and,

WHEREAS, the Colerain Boosters, Inc. supports Colerain’s’ student athletes and performers through various fundraising efforts; and

WHEREAS, a significant source for fundraising revenue may be generated through the Boosters’ Gala; and

WHEREAS, the Boosters will serve/sell alcoholic beverages (beer, wine, and spirits) at the event; and

WHEREAS, the Board and the Boosters have decided to enter into this Memorandum to clearly set forth the Agreement to permit the Boosters to utilize a defined area of the high school and to allow the sale of alcoholic beverages on School District property subject to the conditions set forth herein.

NOW, THEREFORE, BE IT AGREED, by and between the Northwest Local School District Board of Education and the Colerain Boosters as follows:

1. The Colerain Boosters shall have permission to use the Colerain High School gymnasium, football stadium and surrounding areas and parking lot on March 15, 2025, from the hours of 12:00 p.m. to 11:59 p.m. for hosting the Boosters' Gala fundraising event. The High School is located at 8801 Cheviot Road, Cincinnati OH 45251.
2. The Boosters must comply with any and all requirements of the Board's facility use regulations.
3. In the event the Boosters obtain a valid permit for the sale of alcoholic beverages in accordance with Ohio Revised Code §4303 et al., the Boosters may sell beer and/or wine at the event on March 15, 2025 in compliance with the requirements of any said permit issued by the Ohio Department of Liquor Control.
4. The Boosters shall collaborate with the District's High School Principal, and the Superintendent, or his designee, for the provision of appropriate police and fire safety personnel at the premises for the security and safety of those attending the event. This shall include an appropriate plan for traffic safety to include ingress and egress along Cheviot Road before, during, and after the hours advertised for the event.
5. The Boosters will ensure that any bartenders and/or servers of alcoholic beverages are not consuming alcohol and are taking appropriate and reasonable precautions from over-serving attendants. Furthermore, the Boosters will ensure no person under the age of 21 is not permitted to attend the event, therefore no one under the age of 21 will be served alcohol.
6. The Boosters shall maintain liability insurance in the amount of not less than One Million (\$1,000,000.00) Dollars for any liability related to the event which shall not exclude the sale or service of alcoholic beverages at the event.
7. The Boosters shall reimburse the District the cost of three (3) custodians on duty for the event from 5:00 pm to the conclusion of the event.
8. The Boosters shall be responsible for clean-up and returning the High School Gymnasium and surrounding areas and parking lot to its conditions prior to the Boosters' use and ready for school on March 17, 2025.
9. This Memorandum shall constitute the full and complete understanding of the parties concerning this matter and any amendments or modifications shall be in

writing and signed by the parties.

I want to thank the kids from The Hope Squad. I don't know if they realize how much they can help people when it comes to suicide. I really appreciate Mrs. Miller and the students for putting the time in to address a problem that's pretty prevalent today.

Ms. Slattery: I would like to congratulate all the teachers that were awarded tonight. I think the strong point that came through is that they're caring, they're understanding, and they want the best for their students. I think it's wonderful that they're providing a great role model for these students.

I think the Hope Squad is a wonderful thing, for the kids to help each other and be available as somebody who's your peer. They're someone that you feel comfortable reaching out to who can then lead you to further help.

Mr. Gilbert: I just want to reiterate what these guys have said. The two things that stand out for me are our amazing Educators that were here this evening. I can't even comprehend what they put into this. We know when they're in the building and out of the building but there's a lot going on behind the scenes. 
