# NORTHWEST LOCAL SCHOOL DISTRICT RESOLUTION NO. \_\_\_\_

AUTHORIZING A CONTRACT WITH SHP FOR PROFESSIONAL DESIGN SERVICES ASSOCIATED WITH THE STABILIZATION AND PRELIMINARY REMEDIATION OF THE MASONRY FAÇADE FAILURE AT COLERAIN ELEMENTARY SCHOOL UNDER OHIO REVISED CODE 153.71(B)(3), RECOGNIZING AN EMERGENCY REQUIRING IMMEDIATE ACTION AND WAIVING COMPETITIVE PROCUREMENT REQUIREMENTS.

**WHEREAS**, the Board of Education of the Northwest Local School District (the "Board") desires to immediately undertake the repairs associated with the stabilization and preliminary remediation of the masonry façade failure at Colerain Elementary School; and

**WHEREAS**, the services and repairs must occur without delay to prevent further damage to the building and infrastructure; and

**WHEREAS**, compliance with the procedures for the advertisement of bids prescribed by Ohio Revised Code §3313.46 will unduly delay the work and threaten the normal operations of the Board and the health, safety, and welfare of students, staff, and visitors, and may cause further damage to the building; and

WHEREAS, the Superintendent recommends approving a contract with SHP for professional design services associated with the stabilization and preliminary remediation of the masonry façade failure at Colerain Elementary School (the "Project") based upon ORC 153.71(B)(3), recognizing the current circumstances give rise to an emergency requiring immediate action and waiving competitive procurement requirements; and

**WHEREAS**, SHP is a qualified provider of professional design services and has a long-standing relationship with the District; and

**WHEREAS**, SHP has provided the District with a contract for services on the Project in an amount not to exceed \$50,000 dollars; and

**WHEREAS**, the Board understands and agrees that other contracts may also be necessary to dispense with the provisions of Ohio Revised Code 3313.46 in order to prevent the further damage to the building and infrastructure, and that all contracts pursuant to this section will be ultimately presented to the Board for approval

NOW, THEREFORE BE IT HEREBY RESOLVED BY THE NORTHWEST LOCAL SCHOOL DISTRICT BOARD OF EDUCATION AS FOLLOWS:

#### **SECTION I**

Pursuant to Ohio Revised Code §3313.46, it is found and determined that there is an urgent necessity and need for entering into a contract for the professional design services associated with stabilization and preliminary remediation of the masonry façade failure at Colerain Elementary School.

### **SECTION II**

It is further found and determined that compliance with the bidding procedure contained in Ohio Revised Code §3313.46 would unduly delay the work and threaten the normal operations of the Board and the health, safety and welfare of students, staff and visitors, and may cause further damage to the building.

#### **SECTION III**

Earlier this month the District experienced a failure of a portion of the masonry facade at Colerain Elementary School which created an immediate safety concern for the building and its occupants. The District has been proactive in evaluating the structural integrity of the building and installing safety measures to protect the building site and its occupants. The situation presents an emergent and immediate need for professional design services to provide further assessment of the building and site, implement necessary safety measures and temporary protections, coordinate site stabilization and preliminary remediation efforts, and to assist the District in identifying a long-term solution. The District will need to work diligently to investigate and mobilize a plan of action prior to the start of the 2024-2025 school year. Procuring design services through the qualified emergency exception of Ohio Revised Code §153.71(B)(3) affords the District the ability to respond to this matter immediately and without delay, as time is of the essence. The Board requires the immediate services of a design professional for work on the Project. SHP is a qualified provider of professional design services and has a long-standing relationship with the District.

#### **SECTION IV**

SHP has provided the District with a contract for services on the Project in an amount not to exceed \$50,000 dollars. The Board authorizes the Superintendent and Treasurer to enter into an agreement with SHP for professional design services for the Project. The President and Treasurer are hereby authorized to execute any necessary contract documents for the work.

## **SECTION V**

The Board hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Board; and that all deliberations of this Board and its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

# **SECTION VI**

This Resolution shall be in full force and effect from and immediately after its adoption and shall

supersede any prior resolution or act of this Board which may be inconsistent with or duplicative of this resolution.
