#### Resolution of Job Abandonment

Resolution recognizing that Ashley Hammond has abandoned her position with the Northwest Local School District Board of Education effective September 29, 2023. The District has attempted to be in contact with Ms. Hammond to have her fulfill her contractual duties to the Board. However, Ms. Hammond has refused to fulfill such contractual

duties. This job abandonment is not done with the consent of the Board of Education, and this resolution should not be seen as "consent" under RC 3319.15. This resolution is passed only to recognize the job abandonment so that the District administrative offices can do what is necessary to remove Ms. Hammond from the District's employment rosters and other systems.
